**Guest:** 

Peter Rowsell spoke with council regarding persons speeding on MountainVale Park. Mr. Rowsell suggested to council that he would like to see a speed sign installed on Mountain Vale Park (40 km/h). Mr. Rowsell also stated that the hearing-impaired sign needs to be moved as it is not visible enough for people to see. Mr. Rowsell would like to see more RCMP surveillance. The Mayor stated that a sign will be installed regarding speed limit and the hearing-impaired sign will be moved. As for the RCMP they can request they come but can't make them show up. Town Clerk/Manger to direct the maintenance person to erect the speed sign and move the hearing-impaired sign.

# (<u>4</u>) Committee reports

# 4.1 OPERATIONS AND PUBLIC WORKS:

- 4.1.1 Artesian Wells – Jerry Lahey with Department of Environment and Water Resources suggested that the town contact Dorothea Hanchar who is also with Department of Environment & Water Resources as the issues with the water falls more in her job description than Jerry's. The Town Clerk/Manager touched base with Dorothea and she suggested that the town should consult with a consultant before moving forward. Dorothea provided contact names of consultants. Council requested that the Town Clerk/Manager engage with the consultants.

Councillor Dawe stated that he was in contact with John Sparkes and will be setting up a meeting with council soon. Mayor Thistle asked if he would fall in the scope as a consultant. Councillor Dawe stated that John Sparkes is a Public Engineer.

The town of Steady Brook needs to speak with a consultant before they do any drilling.

- 4.1.2 PRV Chambers – Pasadena was out and assessed the town's PRV chambers as the town has no one qualified to do the work at this time. They informed the Town Clerk/Manager of the parts that needed to be ordered and will come back and show the maintenance person how to repair the chamber.

The Mayor stated that the town of Pasadena has agreed to help

the town out until the maintenance person is comfortable to do the work himself.

- 4.1.3 Injection Pump Kit The town received notification from Pennecon that the pump kit in the chlorine building need to be replace every year, this is part of regular maintenance. Council requested that the Town Clerk/Manager get some more quotes besides the one that we received from Pennecon in the amount of \$1185.00. The Town Clerk/Manager is waiting on the quotes to come in.
- 4.1.4 Hi-Tech Communications The town needs to install a tower on the new municipal building in order for the communication radios to work. The current tower on the old municipal building is not long enough, therefore a new one needs to be installed. The price of the installation of the tower and the tower itself is \$2217.54.
