#### 4.1 OPERATIONS AND PUBLIC WORKS:

4.1.1 Snow Clearing – Operations Manager requesting to hire a part-time person for snow shoveling.

Note there is approved funding left in this year's budget and money has been allotted for 2019 budget.

# 4.2 EMERGENCY MEASURES:

4.2.1 Fire Hall – Electrical Upgrade – The Municipal Building located at 1 Wilton Street requires an electrical connection that was not installed when the building was built for the Fire Truck. Operations Manager received three quotes and picked the appropriate contractor to do the work. The cost of the upgrade is less than \$2000.00.

Mayor Thistle spoke to the motion, All of Council and staff spent a lot of time on the budget. The Town's overall tax revenue was impacted due to changes in the Municipal Assessment 2019 roll book. However, the impact was minuscule. The Equal Payment Plan will be brought back in 2019 as it did not go over well last year with the residents. The Town will offer a 2% discount to residents if paid by March 31, 2019. The mil rate will remain at 6 mils. There is zero room in the budget to do anything much extra in the Town.

The Mayor asked if anyone else would like to speak regarding the budget.

Mr. Dawson stated Council did a good job with the preliminary work of the budget. He has some concerns with the budget which is mostly around HR issues, unfortunately those issues he has not yet been given the opportunity to discuss prior to the budget. Council has scheduled a meeting to discuss his concerns. Mr. Dawson was glad to see council put the 2% back in the budget and that they are bringing back the Equal Payment Plan. Councillor Dawson complimented the work on the budget. Mayor Thistle thanked Mr. Dawson's for his contributions to the budget.

4.6.3 – Operations Manager Expenditure – Mayor stated in the past managers had spending approval. A motion needs to come forward to give the Operation's Manager approval for expenditures.

The Mayor said it is a formality to allow the expenditure.
