# **4.1 OPERATIONS AND PUBLIC WORKS:**

- 4.1.1 Municipal Building Councillor Wilton reported to council that as per discussion with Steve Osmond that his work regarding the Municipal Building at Anderson Engineering is completed and has been forwarded to Walter Anderson at the Firm for final review and then will be sent to Municipal Affairs for approval to go to tenders.
- 4.1.2 Artesian Wells Councillor Wilton reported to council that we received a letter back from MHA Eddie Joyce proposing that the Town wait before requesting additional funding until we get the result of the re-tendering package as it is premature to speculate what the Artesian Well Project # 14058 may cost. Councillor Wilton Spoke with Steve Osmond at Anderson Engineering, the Engineering firm would like to see it go to tenders in February and has put a request in to Municipal Affairs asking to go to tenders earlier than March 2016, the Town of Steady Brook supports this request and acknowledged this to Municipal Affairs.

Mayor Rowsell stated that he had received a call from CBC looking for an update Mayor Rowsell had nothing new to update the media with. Mayor Rowsell addressed the public in council chambers and told them that this project has been on the agenda for the last two councils before him and that the Artesian Wells Project # 14058 has been a very slow process.

- 4.1.3 Town Mapping Councillor Wilton stated that the Town of Steady Brook has requested that Anderson Engineering provide the town with digital mapping of water mains, sewer mains, pressure relief valve chambers (PRV) fire hydrants etc. Anderson Engineering have started to work on the proposal.
- 4.1.4 Regulator for Chlorine Councillor Wilton stated that the parts are in and that the repairs have been done by Western Pumps.
- 4.1.5 Generator One of the Town's Generators is not working properly, three quotes were provided to the Town of Steady Brook.

Councillor wells noted that we have a resident who sits on the committee as well (Fraser Dwyer).
- 4.1.7 Water Readings Councillor Wilton stated that the Towns water readings in the last three to four months have gone down considerably per gallon per minute. Maintenance workers found three major leaks in the Town a few months ago and fixed them accordingly. This is great news for the town as we are using less water than what we thought and with the new Project coming on board in the near future we will have amplitude water to run the Town of Steady Brook, However the town advises that we still need to be conservative with the new water supply when it comes on line.
