Resolutions Arising of Minutes NOTHING TO REPORT. **Delegations &** Guests (4) Committee **4.1 OPERATIONS AND PUBLIC WORKS:** Report 4.1.1 – Maintenance Councillor Diamond explained the Lift Station on Musgrave Drive once again needed to be serviced. It was determined Swiffer cloths are being flushed into the sewer system and posing major problems to the Lift Station. Maintenance Staff called in a contractor to pull the pump and fix the issue. Councillor Diamond

noted this is becoming a habitual problem and is generating

unnecessary expenses for the Town. This problem with the Lift Station is avoidable.

Mayor Dawson stated another letter was sent to residents on Musgrave Drive outlining the severity of the situation and included photographs.

Mayor Dawson explained Musgrave Drive Lift Station services 11 properties and if this issue continues, the sewer will eventually back up into the properties on Musgrave Drive. He also noted Council is exploring options to narrow down the property causing the issue, as if this continues, the Town may have to increase taxes to accommodate the unnecessary Lift Station expenses.

Councillor Diamond reported maintenance staff is doing a great job with snow-clearing and widening roads around Town to accommodate the amount of snow in the last few weeks.

4.1.2 – Purchase of New Truck

Councillor Diamond reported the Town has received the new Truck. Maintenance staff have returned to performing daily activities which was previously limited due to the reduction of equipment.

Mayor Dawson asked if anyone would like to speak to the motion.

Councillor Diamond explained the Town was approved for a Water Filtration System however, Council is planning on doing a "study" regarding the water source prior to starting any water improvements.

Mayor Dawson agreed the Town has been approved for a water filtration system upgrade. However, Council has determined it is necessary to do a study on the source of the water intake before determining the type of filtration system to install. The funding for the upgrade to the filtration system has been approved but the water source needs to be looked at prior to any construction to help the Town verify the proper system. He further explained the Town currently blends its water and the Town is the only community nationally blending its water. Council determined it is necessary to look at various options for the water source and will apply for a Long-Term Water Infrastructure Plan.

Councillor Diamond explained there is nothing new to report and the Town is waiting to hear if the application has been approved.

regional governance and how surrounding communities can share municipal services. GHJC applied for a \$50,000 grant and received a \$15,000 to do a study on this topic. GHJC plans to request additional funding from Municipal Affairs for this study.
