# **4.1 OPERATIONS AND PUBLIC WORKS:**

- 4.1.1 Artesian Wells The Town of Steady Brook is still waiting on the parts in order for the pumps to be lowered in the Artesian Wells. Anderson Engineering will advise the town when the parts will soon be here so maintenance can prepare for the work to commence. An email will go out to residents informing them when this will happen.
- 4.1.2 Asset Management The Town of Steady Brook will be applying for a grant from FCM for GIS Integrated Mapping. This will be cost shared, with the town paying 20% of the cost. Asset Management will help the town capture and complete inventory for all major assets such as water distribution, sewer storm, and roads as well as municipal owned buildings. Asset Management will help generate reports on life expectancy, condition and replacement costs for all asset groups.

Where as putting Asset Management in place the town can effectively manage new & existing assets & services. With the intent to maximize benefits, reduce risks and provide level of service to the community in a sustainable manner.

Mayor Thistle wanted the following stated in the minutes. WRWM first initial roll out was to start the first of July, WRWM never got their act together and postponed it until the 16<sup>th</sup> of July. The mailout Sort It Package happened around June 26. Anyone who does not accept flyers are completely out of the loop on the new Sort It Program. So, because of that the Town of Steady Brook will have a garbage problem on July 16, 2018 due to everyone not getting the package. Town council stated everyone should have had one put in their mail box regardless if they received the flyers or not.

## 7. COUNCILOR'S / MAYOR FORUM:

Mayor Thistle inquired about the trails and when CBSTD was going to be starting the Look Out on Marble Drive by the Wetlands. Town Clerk/Manager stated that CBSTD informed her they were waiting on the JCP grant to start. Mayor Thistle didn't think the JCP grant would have anything to do with the start of the Look Out as this would require experience Engineers and Tradespersons to do the work.

Action: Mayor Thistle asked the Town Clerk/Manager to email Brent Humphries for verification when the work will start on the Look Out.

It's been six years since the start of the trail development.

Deputy Mayor Wells inquired about the Interview that Mayor Thistle had with CBC Radio regarding development at the base of Marble Mountain. Mayor Thistle stated the interview went very well, she stated in the interview, a member of council needs to be on the board and a meeting held with council before any infrastructure could start. The Mayor stated that she got some great feedback from the residents complimenting her on her interview and how she conducted the interview.

Councillor Howlett spoke regarding the playground and some safety issues the town may have with some of the aging equipment. Council would like the appropriate signage put on the equipment, such as parental supervision required.

**Action:** Town Clerk/Manager to order signage.

Much discussion on the aging infrastructure, Mayor Thistle stated that we get a quote from Tract Consultants for a complete

redesign of the whole playground.

<u>Action:</u> Town Clerk/Manager to reach out to Tract Consultant for a quote.

Once council can find out the cost for the quote to revamp the playground hopefully the Town of Steady Brook can apply for funding with Recreation NL.

Councillor Austin stated it came to her attention there is a lot of profanity language on the playground form the older children and the smaller kids are subject to the language and can be intimidated by the older ones. After some discussion on this issue council would like the Town Clerk/Manager to send out an email to the residents letting them know that if the smaller children are being unsupervised, their children are subject to such bad language. Unfortunately, the playground is an unsupervised playground.

<u>Action:</u> Order proper signage for playground – Foul Language not permitted in playground.
