- 4.1.3 - Lagoon - Biomaxx - Council is in agreement to get Biomaxx to do the monitoring for the Town of Steady Brook, however council would like to see if they can get a flow meter cheaper than the one that Biomaxx quoted the town for. The Town Clerk/ Manager will call K&D Pratt and see what price they have on a out-flow meter and the cost to install. Than council will decide whether to go with Biomaxx or K&D Pratt. Town Clerk/Manager will inform council via email when she receives information from K&D Pratt.

Councillor Gillette stated that there may be funding from the "green fund" for waste water. The Town Clerk/Manager will see what information she can find out on the "green fund".

Councillor Wells suggested giving MHA Scott Reid a call and he may be able to point the Town Clerk/Manager in the right direction.
