## 4.1 OPERATIONS AND PUBLIC WORKS:

4.1.1 Water and Sewer Critical Maintenance – RFP

Operations Manager reported that the Town is looking into a possibility of a new water filtration system by the end of the year. Currently, there is a Capital Works Project Application (Provincial Level) submitted by the Town. The water system that is in place now is not addressing the contamination issues as the system is drastically affected by sediment buildup in the PRV chambers. As a result, in order to have clear water, we need a more complex system with newer technology. A complex system will also require expertise and properly trained staff. The Town will have to adjust staff and training levels accordingly. In order to have quality water, there is an associated cost. Operator hours, chemicals needed are just some of the things that increase the cost for an improved water system. The current budget to operate the water system for the Town is far below what is needed to maintain the system properly. As a result, taxes will need to go up next year to provide clean water in Steady Brook. This is a discussion that will take place with the Finance Committee and presented to Council in the near future. RFP will need to go out regarding water system. Currently, \$3000 -\$5000 is required for system maintenance work. This must be done to fix a leak that was discovered recently. We are waiting on the parts. This work would be considered emergency/critical as our current system requires this to be done to operate effectively.

# 4.2 EMERGENCY MEASURES:

4.2.1 Fire and Emergency Service Newfoundland and Labrador Firefighting Equipment Program – C. Howlett spoke to the motion as the Steady Brook/Little Rapids Fire Dept are upgrading SCBA (Self Contained Breathing Apparatus) and requiring the signature of the Mayor for this application. The monies will directly come out of the Steady Brook/Little Rapids account.
