(4) Committee 4.1 OPERATIONS AND PUBLIC WORKS:

- 4.1.1 Artesian Wells – The town is currently blending 70/30 on the Artesian Wells.

Town Clerk/Manager stated that as per request of council that Jerry Lahey will be meeting with council on March 20, 2018 to discuss options to improve our water quality and quantity.

a rear dump valve. These two additions did not come with the truck when it was ordered. It is much cheaper to add these changes while the truck is being custom built than to add after the town receives the truck.
